PARENTS IN RENTED HOUSE SCHEME 2020-21

in the loving memory of our beloved father and founder-chairman of this institution Shri Jagdish Lal Bhatia, “PARENTS IN RENTED HOUSE SCHEME 2020-21” in short “PRHS 2020-21” has been launched by school management today on 29/10/2019, the day when he left us five years ago, with effect from 01/04/2020 for the session 2020-21 and this scheme is completely financed and arranged by the school itself and nothing is granted by any of the agencies of the govt. or any kind of the NGOs. **School management has decided to promote the expansion of imparting education among those poor categories /portions of the society by launching this scheme who are not having their own house in Delhi/NCR of Delhi** in other words they are residing in the rented- house but they are doing their jobs over there for their livelihood.

If the parents want to avail the benefits of this scheme then they have to submit an affidavit on a stamp paper of Rs. 10/- mentioning the points given below and **hope parents will provide the correct information in their affidavit** and after receiving an application with an affidavit **school will conduct an enquiry at its own level** before giving the admission in the school.

During the session **if any of the information mentioned in affidavit is found false or wrong then school has right to withdraw the benefits given to children** of that parent and **school will not be responsible for any kind of loss or damage of the future** and waste of the year of the kids of that

parents so the parents are advised to give the true and correct Information in their affidavit so that relations between the parents and the school could remain healthy.

Under **“PRHS 2020-21”** the parents can avail a **big benefits in such a way that if they have two or more than two kids for admission** in the school then they have to purchase a **complete book set themselves for their elder-one** and they may get a **complete book-sets free of cost for their younger kids at the time of admission** and they may get the **same benefit in the next year at the time of promotion to the next classes after submitting their annual charges** excluding the elder-one with all other charges accordingly.

- F. If any of the points mentioned above is found wrong or any information given by the parent is found wrong then school has right to withdraw all the benefits under the **“Parents in Rented House Scheme 2020-21”**.
