parents are advised to give the true and correct information in their affidavit, If the parents want to avail the benefits under the "WOS 2020-21" they have to submit an affidavit mentioning that :-

- A. He/she is the guardian of the (name of the student) and ready to bear all the expenses levied by the school.
- B. His / Her mother/ father has expired on (date)
- C. He/she is the sole earning hand in the family.
- D. His income from all the sources is less than rupees two lakh only (Rs.200000) per annum.
- E. He is not having any four wheels pvt. /commercial vehicle.
- F. If any of the points mentioned above is found wrong or any information given by the parent is found wrong then school has a right to withdraw all the benefits under the "WOS 2020-21".
- 1. Guardians have to pay half charges of all of the fees accordingly for all the kids at the time of admission and half transport charges payable in twelve months. All the books and a set of uniform (summar & winter) will be provided at the discount of 50% to all the kids studying in our school under this scheme and an extra set of uniform can be purchased without any concession by the parents in order to send their kids in neat n clean uniform.
